On behalf of the California Lawyers Association, I am delighted to inform you of your appointment to the Privacy Section's inaugural Executive Committee. We are deeply grateful for your commitment to our dynamic, evolving bar association. Thanks to you and volunteer leaders like you in CLA's various Sections and Committees, our members have the opportunity to make invaluable connections, gain visibility, contribute to extraordinary continuing legal education and help lead the profession in the state of California. If, for some reason, you are unable to accept this appointment, please notify us immediately.

You will separately receive a Doodle Poll to schedule your first Executive Committee meeting. At that meeting, it will be important to discuss crucial topics including identifying your officers and Board Representative and reviewing and revising your administrative bylaws. Draft bylaws are attached for your review. We have noted some changes you will likely want to make to the draft, including allowing anyone (not just California attorneys) to serve as officers. Please let Tricia know if you are interested in serving as the Chair, Vice Chair, Secretary or Treasurer during your first year. We will assist in compiling a list of candidates and scheduling time for you to make brief statements at your first Executive Committee meeting when your committee votes on its initial officers. Tasks like identifying other leaders for marketing, publications, etc. may be handled by your committee when you deem appropriate.

Executive Committee members typically serve a term of three years, with 1/3 of the committee joining each year, and 1/3 of the committee concluding its term annually. To establish initial terms, we have placed you into categories of three-, two- and one-year terms. Certainly, at the end of the first year, it would not be surprising that some of those who have served will apply to serve another three-year term.

There will initially be 16 members, divided into the categories selected round-robin style, alphabetically:
